1. This lifejacket light is for attachment by recessing into buoyancy foam only, lifejackets are to be of types specifically designed for this.
2. Replacement of the batteries is not allowed and their removal should not be possible without destroying the container. The light unit must be replaced on or before the expiry date marked on its label.
3. Detailed fitting, maintenance and in service test instructions are to be provided to each purchaser of the subject lights.
4. Each light is to be marked with the information required by the LSA Code Regulation 1.2.2.9.
5. The lifejacket type where the subject design of light is fitted should be tested in accordance with IMO Resolution MSC.81(70), I/10.3.3 to confirm the adequacy of their means of attachment.
